



Vaccination is required to travel on all international tours starting on September 1, 2021 through December 31, 2022 so that our travelers can enjoy every aspect of the tour they've purchased. We will continue to review and update our policies as requirements change.

Many countries are now requiring a booster dose at least 14 days before travel if the traveler was fully vaccinated more than 6 months before travel. As such, we strongly recommend that travelers plan to receive a booster dose to avoid any challenges entering the destination country or experiencing components of the tour.

Please reference the chart below so you are completely up to date on the requirements of your tour's destination(s). While this information was current as of the time of update, these requirements are always changing. It is important that you frequently check the entry/exit requirements for your destination(s), including up until the time of your departure, to ensure you are aware of any changes that may be applicable to your travel plans.
